Good morning, members of the Eastern Sierra Council of Governments,

I would like to provide an update regarding the Emergency Rent Assistance Payment Program. Our program currently pays up to \$500 towards a maximum of four rent payments, for households living in Mono County that have experienced a loss of income due to the COVID-19 pandemic.

Our program has truly been a success because of our partners and neighbors that have contributed financially. We have received contributions from the Town of Mammoth Lakes, Mono County, First 5 Mono, CA Coalition for Rural Housing, and private donations for more than \$600,000. Through our fundraising efforts, MLH has secured more than \$20,000 from individual donors to support this program.
